Audience comments were received on the following items:

- Ongoing problem with parking in tree lawns; blocking the sidewalks in Morningside and Deer Run.
 - The Board advised they cannot cite Residents since it is not a deed restriction matter; this is an issue for Law Enforcement to handle.
- Facebook Petition against a 7-Eleven development.
 - The Board advised a letter was sent to the Pasco County Commissioners stating the District's opposition. It was noted the CDD cannot expend funds against this opposition or lead any such effort.

B. Deed Restriction Violation Appeals

- > DR 2017-172 at 1938 Fellsway Ct.
 - o An appeal request was presented by the homeowner; the Board reviewed the information.
 - O Violations were not corrected within the time allotted. The driveway was cleaned but the stain remains.

 Λ 30-day extension was granted to allow the homeowner to provide proof of compliance.

On MOTION by Mr. Aleo seconded by Mr. Bovis to extend the timeframe by 30 days for homeowner to have driveway professionally cleaned; the CDD to waive the fine and impose administrative fee costs of \$150.67, following affirmation of compliance for the DR 2017-172 appeal.

Discussion followed.

On VOICE VOTE with Mr. Bovis, Mr. Picarelli, and Mr. Aleo voting AYE and Ms. Sanchez and Mr. Cline voting NAY to waive the fine, following affirmation of compliance within 30 days; and to impose administrative fee costs of \$150.67 for DR 2017-172 appeal. Motion carries 3-2.

C. Operations Manager

Ms. Diaz reported the CDD Packets are now available online; they were emailed to the Board and a printed copy was also provided.

- Spring Garage Sale
 - o Meadow Pointe III date is March 24, 2018.

Pool Service

- Contract with current vendor Finley Pool Services ended December 31, 2017 and they are currently providing service on a month-to- month basis.
- Proposals were included in the Agenda Packet and discussion can be scheduled for review at the next meeting.
 - o Positive Pool Service offers pool service six days per week.
 - o Finley Pool has not yet submitted a proposal.

D. Discussion Regarding Issuance of Bonds

On MOTION by Ms. Sanchez seconded by Mr. Picarelli to proceed with discussions on a future issuance of a bond to cover roadways, tree removals and other projects.

On VOICE VOTE with Mr. Picarelli, Mr. Aleo, Mr. Bovis, Ms. Sanchez and Mr. Cline voting AYE to proceed with discussions on a future issuance of a bond to cover roadways, tree removals, and other projects was approved. 5-0.

- **E.** Mr. Cline provided information regarding the situation with Fire Station 26.
 - Pasco County entered into an agreement with Hillsborough County to provide ambulance and fire service to areas in Hillsborough County; specifically Pebble Creek, Cross Creek, Live Oaks and Wharton High School.
 - o The \$275,000 agreement does not seem to be enough to cover the cost for 6 additional staff and use of Pasco County fire department equipment.
 - O Three other fire stations in Pasco County will now be responding to calls from Meadow Point II which will significantly affect emergency response times.
 - Our community will be disadvantaged in the following ways:
 - The fire-emergency response to Hillsborough County will be used as justification for connecting Kinnan and Mansfield roadway; Pasco County residents will be paying a portion of the bill for the road opening.
 - A lapse in fire-emergency response time provided to Pasco County residents will be created.
 - The amount of money negotiated for this contract agreement cannot support the proposed staffing and depreciation costs for the equipment.

 It was noted residents should reach out to Commission Moore to provide their comments and input.

 - o Yes it follows the CPI.

Supervisor Comments

Mr. Bovis:

> Please reach out to Commission Moore to voice your comments and concerns regarding the roadway opening.

Ms. Sanchez:

There are mixed feelings within the community regarding the opening of Kinnan Road. The District has taken a position against the opening of the road. There will be a significant increase in traffic from Hillsborough/Tampa onto a two-lane road in our community since there are areas where it is not expandable to four lanes. This will have a detrimental impact on the safety of the residents in our community.

Mr. Picarelli:

- > Supporting the road opening for use a shortcut is at the sacrifice of all the bad things associated with it.
- > The letter Mr. Cohen wrote to Verizon/Frontier regarding Verizon cables buried in the tree lawns was appreciated.

Mr. Cohen noted Frontier received the letter and responded. They were directed to contact the District Engineer, Brad Foran who will be meeting with them onsite.

Mr. Foran stated when he meets with Frontier they will be advised where the stump grinding will occur. At their cost, they will be given the option to relocate the lines or otherwise protect them from damage.
